

**RELEASE, INDEMNITY AND ASSUMPTION OF RISK**

I am signing this Release so that my child can participate in Camp Catanese. This Release, Indemnity and Assumption of Risk covers all events and occurrences associated with Camp Catanese, the Camp Catanese Foundation, Pueblo Del Sol and the Isaac School District, and Arizona State University. I understand that if I have any concerns about my child's health or ability to participate, it is my responsibility to discuss my concerns with my physician before deciding to participate.

In consideration of the acceptance of my child's application for Camp Catanese, and my child's ability to participate in same, we hereby waive, release, and discharge any and all claims for personal injury or property damages which have occurred or which may hereafter occur to me as a result of my child's participation in Camp Catanese. I agree to assume the risk that unexpected events may occur and could potentially result in harm, injury, illness, or even death to my child or damage to my property while my child is participating in or observing Camp Catanese.
